104b Cumbria County Planning Obligations Policy

Cumbria County Council is seeking views on its draft Planning Obligations Policy document. A policy framework has been prepared to ensure new development provides sufficient infrastructure to meet the demand created by that development where provision is not already available. Fair and reasonable contributions towards the cost of the provision of additional highways, transport, surface water management, adult social care, education and safer communities infrastructure will be sought by the County Council where it is needed to ensure the requirements of a development can be met.
