	LAA working group contact list – new member, therefore, the list needs emailed to the group again.
	Anti-social behaviour (ASB) in Cockermouth - company to be approached with regards to free trial/demo – Mike Rollo advised that he had spoken to the company and they were happy to do either. The group felt this would be a good idea so that they could see how they work and then decide whether they could help with ASB, or any other issues.
	Moveable surveillance cameras used in Aspatria – Phillipa Meunzberg to be emailed to get feedback from Aspatria as to whether these cameras have worked in Aspatria.
	CCTV not being directly linked to police – Mike Rollo had been given Dennis Kelly's name as a contact to discuss this. ADT were to contact police to sort out the link issue, however, the problem is currently ongoing. Mike Rollo to chase this with Dennis Kelly.
	ISS Cockermouth Cemetery Depot – Bob Henderson advised that ISS had been chased on this. They said the work had been done; however, it has not been done to the required standard. Bob Henderson to continue to chase this matter.
	Cockermouth greenway clean-up day – Tracey Martin to email Nikki Wingfield to see if the clean-up day will be going ahead.
	Main Street improvement proposals – Les Tickner went through the plans with regards to this with the group. The group discussed this at length. The group

was asked to attend the drop in sessions on the 24, 25 & 26 November to have a look in more details and put forward their comments. Although, if any members could not attend Dave Bell could be emailed with any concerns.

Eye level cigarette bins to help enforcement – Tracey Martin apologised as this had been missed off the action list and she had only put it on the list that morning. The completion date for this to be moved to the next meeting. Tracey advised though that the Environmental Wardens are currently in the process of commencing a smokefree litter campaign, to raise awareness again with the pubs/clubs in Allerdale Borough Council's area. Tracey Martin to circulate the smokefree leaflet to the PCSO's, as this has some information in that they may find useful.

Waste lane improvements – there are a number of people behind this including the community, councilors' and various agencies. However, some issues have been brought up about emergency access – currently vehicles cannot get down the lane due to the landslide that will need to be sorted out if this works are to be carried out. Bob Henderson to continue to look for funding for this.

#### 3 Anti-social behavior in Cockermouth

The group discussed a number of issues with regards to anti social behavior in Cockermouth. As mentioned previously in the meeting, the moveable surveillance cameras may be able to help with this dependant on how they work. Denise Dervey felt that the work in Workington with Keith Hutton (Youth Engagement Officer) based in Workington Police Station may be able to help with this issue.

Sarah Fletcher to contact Keith Hutton (or Richard Farnworth) with regards to ASB, and whether their projects in Workington could help with ASB in Cockermouth.
