19 Attendance by Police

20 Public Participation

Mr Brian Coley presented a petition from 201 residents of Towers Lane to the Mayor objecting to the construction of two residential properties on land off Towers Lane, Cockermouth.

Members also viewed the scale model Mr Coley had prepared.

Objections centred around the following issues:-

- Interference with tv/mountain rescue transmitter
- Non compliance with 'Building for Life'
- Affect on house prices
- Lack of water pressure
- No public foul sewer
- Access would be dangerously positioned between a bend and a blind dip
- Lack of pavement on the South side of Tower Lane
- The proposed buildings are out of character with existing properties
- The removal of most of the existing hedge which is home to nesting birds and various mammals
- Impaired visual amenity

Members preferred that the fair remain on Fairfield but felt that if this was not an option, moving it to the car park outside Wilkinson's could be a good compromise.
