162c Conservation Area

2017 marks the 50th anniversary of the first introduction of conservation areas in the UK through the Civic Amenities Act 1967.

The current Cockermouth Conservation Area was established in 1975.

There are currently 1,486 properties within the Cockermouth Conservation Area.

The Civic Trust has received a grant of £200 from the IHBC Conservation Areas Anniversary Fund to produce a booklet.

162d Allerdale Local Plan (Part 2): Site Allocations

Allerdale Borough Council is in the process of preparing a Site Allocations Development Plan Document that will form Part 2 of the Allerdale Local Plan. The Site Allocations Development Plan Document identifies sites necessary to meet the Borough's development needs to 2029, as set out in the Strategic and Development Management Policies DPD (Allerdale Local Plan Part 1).
