## Minutes of a meeting of the CLIMATE CHANGE TASK GROUP held on Wednesday 18 August 2021 at 1.00pm in the Council Chamber, Town Hall, Cockermouth

#### 56 Election of Chair

Councillor I Burns was elected chair for the ensuing meeting.

#### 57 Minutes

The minutes of the last meeting were agreed as a correct record.

#### 58 Public Participation

#### 59 Declaration of Interest

#### 61 Climate Change Emergency

Those present which actions had been actioned since the last meeting and which actions should be taken forward during the next quarter.

Recommended – That National Clean Up Day on 18 September be promoted and that the Task Group helps promote/organise litter picking events around town on that day.

#### 62 Peat Compost

Sales of peat compost to gardeners will be banned from 2024. Ministers will also give £50m to support the restoration of 35,000 hectares of peatland by 2025, about 1% of the UK's total.

The UK's peatlands store three times as much carbon as its forests. However the vast majority are in a degraded state and are emitting carbon dioxide which drives the climate crisis.

The Environment Secretary announced £500m to fund a tripling of tree planting in England to reach 7,000 hectares by 2024 and said that a new 2030 target for wildlife populations would be set.

A species reintroduction taskforce was also unveiled to take forward work on recovering species lost to England, such as wildcats and beavers

Agreed – That the measures announced be welcomed and noted.

#### 63 Environmental Project

Further to minute number 206, the Town Council has applied to the Local Area Committee Fund for 168 bags of ladybird larvae plus labour for someone to place these into the trees on Main Street, Market Place and Kirkgate.

The scheme was likely to take place in the Spring of 2022.

Agreed – That the project be welcomed and noted.

#### 64 COP26

In May, the Department for Business, Energy, and Industrial Strategy launched the Together For Our Planet: Business Climate Change Leaders campaign, a new drive to encourage small and micro businesses to commit to cutting their greenhouse gas emissions in half by 2030 and to net zero by 2050 or sooner.

The UK will host the 26<sup>th</sup> UN Climate Change Conference of the Parties (COP26), at the Scottish Event Campus in Glasgow on 31 October – 12 November 2021.

The climate talks will bring together heads of state, climate experts and campaigners to agree coordinated action to tackle climate change.

Businesses who commit by signing up to the SME Climate Commitment will be recognized by the United Nations Race to Zero Campaign. Their mission will be to secure global net zero by mid-century and keep 1.5 degrees within reach, adapt to protect communities and natural habitats, mobilise finance, and working together to deliver.

Agreed – That the Campaign be welcomed and noted.

# COP26: What was agreed at the Glasgow climate conference?

A new global agreement - the Glasgow Climate Pact - was reached at the COP26 summit.

It aims to reduce the worst impacts of climate change - but some leaders and campaigners say it does not go far enough.

#### What was in the COP26 agreement?

The agreement - although not legally binding - will set the global agenda on climate change for the next decade:

#### **Emissions**

It was agreed countries will meet next year to pledge further cuts to emissions of carbon dioxide (CO2) - a greenhouse gas which causes climate change.

This is to try to keep temperature rises within 1.5C - which scientists say is required to prevent a "climate catastrophe". Current pledges, if met, will only limit global warming to about 2.4C.

#### Coal

For the first time at a COP conference, there was an explicit plan to reduce use of coal - which is responsible for 40% of annual CO2 emissions.

However, countries only agreed a weaker commitment to "phase down" rather than "phase out" coal after a late intervention by China and India.

#### **Developing countries**

The agreement pledged to significantly increase money to help poor countries cope with the effects of climate change and make the switch to clean energy.

There's also the prospect of a trillion dollar a year fund from 2025 - after a previous pledge for richer countries to provide \$100bn (£72bn) a year by 2020 was missed. While some observers say the COP26 agreement represented the "start of a breakthrough", some African and Latin American countries felt not enough progress was made.

#### Fossil fuel subsidies

World leaders agreed to phase-out subsidies that artificially lower the price of coal, oil, or natural gas.

However, no firm dates have been set.

A flurry of other announcements were made:



#### **US-China agreement**

The world's biggest CO2 emitters, the US and China, <u>pledged to cooperate more</u> <u>over the next decade</u> in areas including methane emissions and the switch to clean energy.

China has previously been reluctant to tackle domestic coal emissions - so this was seen as recognising the need for urgent action.

#### **Trees**

Leaders from more than 100 countries - with about 85% of the world's forests - **promised to stop deforestation** by 2030.

This is seen as vital, as tress absorb vast amounts of CO2.

Similar initiatives <u>haven't stopped deforestation</u>, but this one's better funded. However, it's unclear how the pledge will be policed.



#### Methane

A <u>scheme to cut 30% of methane emissions by 2030</u> was agreed by more than 100 countries.

Methane is currently responsible for a third of human-generated warming. The big emitters China, Russia and India haven't joined - but it's hoped they will later.



#### Money


Financial organisations controlling \$130tn <u>agreed to back "clean" technology</u>, such as renewable energy, and direct finance away from fossil fuel-burning industries. The initiative is an attempt to involve private companies in meeting net zero targets. However, some environmental organisations have said without a greater commitment to ending support for fossil-fuels, this could be little more than a PR exercise.

#### How will countries be made to meet their pledges?

Most commitments made at COP will have to be self-policed. Only a few countries are making their pledges legally binding.

#### What was COP26 and why was it necessary?

COP26 was the moment countries revisited climate pledges made made under the 2015 **Paris Agreement**.

Six years ago, countries were asked to make changes to keep global warming "well below" 2C - and to try to aim for 1.5C.

COP stands for "Conference of the Parties", and the one in Glasgow was the 26th annual summit. Ahead of it, 200 countries were asked for their plans to cut emissions by 2030.

The goal is to keep cutting emissions until they reach <u>net zero</u> by mid-century. Next year's COP27 summit is in Egypt.

# All new buildings in England to have electric car charge points from 2022

Boris Johnson to announce plans at CBI conference, telling business leaders the UK is at a pivotal moment

Boris Johnson will seek to boost the UK's clean energy credentials after a tricky UN climate crisis conference by announcing that all new buildings in England will be required to install electric vehicle charge points from next year.

In a speech to the Confederation of British Industry (CBI) in the north-east of England on Monday, the prime minister will reveal plans, briefed as "world-leading", to toughen up regulations for new homes and buildings.

From next year developers on sites such as supermarkets and office blocks will be required to install electric vehicle charging points, in an attempt to help phase out the use of petrol and diesel cars before sales of them come to an end in 2030. The government expects the move to lead to 145,000 new charging points each year.

Buildings undergoing renovations that leave them with more than 10 parking spaces will also be subject to the new measures.

Heralding the importance of clean energy just weeks after the UK hosted Cop26, Johnson will say the country is at a pivotal moment, adding: "We cannot go on as we are."

He will tell business leaders that it should not just be public spending that is used to "adapt our economy to the green industrial revolution", but that the government will focus on investment in science and technology, raise productivity and "then get out your way".

Defending the new requirements, Johnson will add: "We must regulate less or better and take advantage of new freedoms."

The government will also support a new loan programme worth £150m, distributed by Innovate UK over three years, to help British small and medium-size enterprises commercialise their latest research. The "innovation loans" will be accessible to a variety of sectors – including green businesses – and follow a pilot with businesses.

A further £9.4m in funding has been confirmed for what Downing Street said was a first-of-a-kind hydrogen project in the UK's largest onshore windfarm, near Glasgow. The money will go to the Whitelee green hydrogen initiative to develop the country's largest "electrolyser" – a system that converts water into hydrogen gas. It is used to store energy and supply local transport providers with zero-carbon fuel.

As part of the government's bid to reach net zero by 2050, almost 26,000 publicly available electric vehicle charging devices have been installed – including 4,900 rapid ones. A total of 250,000 points in homes and workplaces have already been put in place.

Ed Miliband, the shadow business secretary, accused the government of "failing Britain's automotive companies and workers". He said: "Ministers have stepped back and left manufacturers, workers and the public on their own, failing to take the action necessary to make the switch affordable for families hit by a cost of living crisis.

"By extending the help to buy an electric car for those on lower and middle incomes and accelerating the rollout of charging points in areas that have been left out, [Labour] would ensure that everyone could benefit and make the green transition fair."

The prime minister's climate spokesperson, Allegra Stratton, raised eyebrows in August when she revealed she was still driving a third-hand diesel. When asked why she did not drive an electric vehicle, she said: "I don't fancy it just yet."

Stratton, who lives in north London, said this was because of the length of time it took to make trips to visit her father in the south of Scotland, her mother in Gloucestershire, her grandmother in north Wales, and her inlaws in the Lake District.

However, in October, just before world leaders gathered for Cop26, Stratton revealed she had ditched the diesel car.
